**Welcome and call to order:** Vice Chair Ed Crowell presided at the meeting because obligations out of town required that Chair Alyce Spruell participate in the meeting via Zoom. Mr. Crowell called the meeting to order at 11:05 a.m. and welcomed committee members, staff, and guests.

**Declaration of quorum and proper advance notice of meeting:** Vice Chairman Crowell confirmed that a quorum was present and that the board meeting had been announced in advance and in accordance with the Open Meetings Act.

**Adoption of agenda:** Vice Chairman Crowell called for a motion to adopt the agenda. *Senator Singleton moved that the agenda be adopted, and Senator Allen seconded.* 

Members voted by roll call: Gerald Allen – Yes Ed Crowell – Yes Gary Fuller – Yes Bobby Singleton – Yes Alyce Spruell – Yes

The motion passed by a vote of 5-0.

**Approval of minutes:** Vice Chairman Crowell called for a motion to approve the minutes of the last board meeting. *Senator Singleton moved that the minutes of the October 13, 2022, Committee meeting be approved as written and distributed prior to today's meeting. Senator Allen seconded.* Members voted by roll call:

The motion passed by a vote of 5-0.

**Review Membership of the Committee:** A list of the current committee members was distributed in the meeting packets. All existing legislative members were reappointed for a four-year term. Representative Ed Oliver was appointed to the committee by Speaker Nathaniel Ledbetter to fill the vacancy left by former representative Rich Wingo. The governor's appointments office is currently reviewing two existing vacancies: Class 1-3 Municipal Official and County Commissioner

#### Consideration of Applications for Waiver by the City of Tuscaloosa:

<u>Newtown Pocket Park</u>: Tyler Vodopich with the Office of the City Engineer in Tuscaloosa gave a brief overview of the Newtown Pocket Park project. The city would like to relocate the Newtown monument a short distance to a more prominent location in Newtown Pocket Park as part of an improvement project with new sidewalks and landscaping.

Senator Singleton moved to approve the waiver with the stipulation that the brick plinth be repaired or rebuilt to match existing conditions if it is damaged during relocation. Senator Allen seconded.

The motion passed by a vote of 6-0.

**Snow Hinton Park**: Brett Blackburn with the Office of the City Engineer in Tuscaloosa gave a brief overview of the Snow Hinton Park project. The city would like to relocate a monument a short distance within the park as part of an improvement project featuring new walkways and landscaping. Mr. Blackburn explained that the city plans to replace the existing metal monument to Mayor Snow Hinton, which shows signs of deterioration and vandalism. The new monument will be created to match the existing one in content and appearance.

Senator Allen moved to approve the waiver with the stipulation that if a replacement monument is created, it maintains the same content and appearance as the current one. Senator Singleton seconded.

Members voted by roll call: Gerald Allen – Yes Ed Crowell – Yes Gary Fuller – Yes Laura Hall – Yes Bobby Singleton – Yes Alyce Spruell – Yes

The motion passed by a vote of 6-0.

Adoption of FY 2024 schedule for committee meetings and waiver application deadlines: The FY 2024 schedule was distributed in the meeting packets. *Mayor Fuller moved that the proposed schedule of meetings and deadlines be adopted, and Senator Singleton seconded.* 

The motion passed by a vote of 6-0.

Public Comment Period: There were no public comments given.

**Adjournment:** There being no further business, Vice Chairman Crowell called for a motion to adjourn. Senator Singleton moved that the meeting be adjourned. Senator Allen seconded, and the motion was carried by unanimous voice vote.

#### Committee on Alabama Monument Protection FY 2023 Annual Report October 12, 2023

#### October 13, 2022

The Committee met as required by <u>Code of Alabama §41-9-234</u> to elect a chair and vice chair for the following year. Alyce Spruell and Ed Crowell were elected to the positions, respectively. The Committee also reviewed an annual report of activity during FY 2021 and received public comment.

The Committee reviewed and approved applications for waivers for the relocation of three monuments on the grounds of the Autauga County Courthouse: a Vietnam War Memorial, a Korean War Memorial, and a Fallen Law Enforcement Officers Memorial. The applications were made by Autauga County in conjunction with a project designed by Eagle Scout Jonathan Hancock to create a new memorial plaza on the courthouse grounds, on the same block as the existing location of the memorials.

#### February 15, 2023

The City of Tuscaloosa submitted applications for waivers for the relocation of a monument at Newtown Pocket Park and the relocation of a monument at Snow Hinton Park. The proposed relocations are elements of improvement projects to be undertaken at the respective parks. Between February 20 and April 5, the Technical Advisory Review Group and the Office of the City Engineer of Tuscaloosa exchanged correspondence regarding additional details on plans for protecting the monuments during relocation and their new location.

#### April 13, 2023

The Committee reviewed and approved the applications for waivers by the City of Tuscaloosa for Newtown Pocket Park and Snow Hinton Park. In the case of Snow Hinton Park, the Committee gave approval to replace a damaged monument, if necessary, with a new monument with the same content and appearance as the existing one.

#### August 9, 2023

In accordance with <u>Executive Order 734</u>, the Committee created a link on its website <u>homepage</u> to direct visitors to <u>information on submitting public-records requests</u>.

#### August 15 – September 15, 2023

In accordance with <u>Executive Order 735</u>, the Committee undertook a review of its existing administrative rules, producing an inventory of rules containing discretionary regulatory restrictions. The inventory was posted on the CAMP website on August 21 with an invitation to receive comments from stakeholders and the general public by September 12. On September 15, the Committee submitted its inventory to the Office of the Governor for further review.
