Welcome and call to order: Chairwoman Alyce Spruell called the meeting to order at 11:13 a.m. and welcomed committee members, staff, and guests.

Declaration of quorum and proper advance notice of meeting: Chairwoman Spruell confirmed that a quorum was present and that the board meeting had been announced in advance and in accordance with the Open Meetings Act.

Adoption of agenda: Chairwoman Spruell called for a motion to adopt the agenda. *Dr. Rhone moved that the agenda be adopted. Senator Allen seconded, and the motion was carried by unanimous voice vote.*

Approval of minutes: Chairwoman Spruell called for a motion to approve the minutes of the last board meeting. *General Crowell moved that the minutes of the July 14, 2022, Committee meeting be approved as written and distributed prior to today's meeting. Representative Hall seconded, and the motion was carried by unanimous voice vote.*

FY 2022 Annual Report: The annual report for FY 2022 was distributed to committee members in advance of the meeting. Chairwoman Spruell called for a motion to adopt the report. *Senator Allen moved that the FY 2022 annual report be approved. General Crowell seconded, and the motion was carried by unanimous voice vote.* The report will be posted on the CAMP website.

Review Membership of the Committee: There are currently two vacancies on the committee, which include the county commissioner position and the Class 1-3 municipal official. Representative Wingo is not seeking reelection to the legislature, so at least one new member will be appointed by the Speaker in the new quadrennium. All legislative members must be reappointed each quadrennium. A list of committee members was distributed in meeting packets.

Election of Chair and Vice Chair: Chairwoman Spruell opened nominations for chair and vice chair of the committee. *Senator Allen nominated Alyce Spruell as chair. Senator Singleton seconded. General Crowell moved to close the nominations. Senator Allen seconded, and the motion was carried by unanimous voice vote.*

Dr. Rhone nominated Ed Crowell as vice chair. Senator Allen seconded. Senator Singleton moved to close the nominations. Representative Hall seconded, and the motion was carried by unanimous voice vote.

The respective nominees won election by unanimous votes.

Consideration of Applications for Waiver by the Autauga County Commission:

Eagle Scout Jonathan Hancock gave a brief overview of his project to create a memorial plaza on the grounds of the Autauga County courthouse and to relocate three existing monuments from their existing locations on 4th Street to the new plaza, located on the same block. The Autauga County Commission submitted applications for waivers to the Alabama Memorial Preservation Act so the monuments can be relocated. Copies of the proposal were distributed in the meeting packets.

Chairwoman Spruell called for a motion for the Committee to act on the waiver applications. *Senator Allen moved that the Committee act on the waiver applications. Mayor Fuller seconded. The motion was carried by unanimous voice vote, following a brief discussion.*

Chairwoman Spruell then called for a motion indicating that the information provided with the applications is sufficient to establish the ages of the existing monuments. *General Crowell moved that the Committee received sufficient information to establish the ages of the monuments. Senator Allen seconded, and the motion was carried by unanimous voice vote.*

Lastly, Chairwoman Spruell called for a motion to approve the waiver applications submitted for the Vietnam War Memorial, the Korean War Memorial, and the Fallen Law Enforcement Officers Memorial.

Senator Singleton moved that the waiver application for the Vietnam War Memorial be approved. Senator Allen seconded, and the motion was carried by unanimous voice vote.

Senator Singleton moved that the waiver application for the Korean War Memorial be approved. Mayor Fuller seconded, and the motion was carried by unanimous voice vote.

Senator Singleton moved that the waiver application for the Fallen Law Enforcement Officers Memorial be approved. Mayor Fuller seconded, and the motion was carried by unanimous voice vote.

Public Comment Period:

Brief comments were provided by Senator Clyde Chambliss and Attorney Kyle Shirley.

Adjournment: There being no further business, Chairwoman Spruell called for a motion to adjourn. *Crowell moved that the meeting be adjourned. Mayor Fuller seconded, and the motion was carried by unanimous voice vote.*

The meeting was adjourned at 11:45 a.m.

As discussed on the phone, we will be submitting waivers to the Committee on Alabama Monument Protection for the relocation of 2 monuments within the City of Tuscaloosa. Both proposed relocations have been initiated to accommodate improvement projects where the monuments are currently located. No content will be changed on either monument; we are simply proposing to relocate them to a location that better fits the area after the projects are complete.

The waiver application requires "Written commentary from any heritage, historical, genealogical, or preservation organizations

with an interest in the decision of the Controlling Entity, or from the general public". Given your society's mission for the preservation of the history of Tuscaloosa, I thought you would be a good fit for that requirement. I have attached images of both monument plaques, as well as maps showing the existing and proposed locations. A brief summary of each location is provided below as well.

We would greatly appreciate your help in reviewing and providing commentary on this proposal. Our goal is to submit the application by next Wednesday, 2/15. If you have any questions on the relocations, please don't hesitate to let us know; we are happy to discuss!

The Act provides a waiver process for the relocation, removal, alteration, renaming, or other disturbance of any architecturally significant building, memorial building, memorial building, memorial street, or monument located on public property which has been in place for at least 20 years and less than 40 years, and also provides a waiver process for the renaming of a memorial school which is located on public property and has been so situated for 20 or more years. At a minimum, submission of this completed form and attachments constitutes a request for review by the Committee on Alabama Monument Protection (CAMP). The responsibility for preparing this application and all attachments rests with the Controlling Entity that has legal control of the public property on which the architecturally significant building, memorial building, memorial street, monument, or memorial school sits. A Technical Advisory Review Group (TARG) appointed by the Committee shall review the application, verify its compliance with administrative rules, and make recommendations based on the historical and technical scope of the application. The TARG's ability to complete a timely review depends on the quality of the material submitted.

NOTE: The Committee's administrative rules (*Alabama Administrative Code* 584-X-1) provides for a 90-day response time by the Committee following the submittal deadline. A schedule of Committee meetings and deadlines is available at <u>www.CAMP.alabama.gov</u>.

The Newtown monument currently sits near the southwest corner of an underutilized portion of right-of-way that the City of Tuscaloosa plans to develop into a park. The City of Tuscaloosa plans to relocate the monument to a more centralized location within the park; creating a focal point feature. Relocation of the monument would be less than 50 feet and lighting features would be installed to honor the monument. A \$275,000.00 budget has been established for the park with the cost to relocate the monument included within the budget. Design of the park is expected to be completed by the end of March and project completion is expected by the end of August.

5. Explain the origin and significance of the architecturally significant building, memorial building, memorial school, monument, or memorial school. Describe the intent of the sponsoring entity at the time of dedication and any subsequent alteration, renaming, or other disturbance. Attach copies of available documentation.

The Newtown monument was contributed in 1990 by Councilman Charles Steele Jr. to commemorate the Historic New Town of Tuscaloosa, otherwise known as Newtown. A placard on the monument layouts the original boundaries of Newtown as well as historic milestones significant to the former Newtown area.

6. Provide a written statement of any facts that were not known at the time of the origin of the architecturally significant building, memorial building, memorial street, monument, or memorial school, but are known now that the Committee should consider.

Recent improvements to Martin Luther King Jr. Boulevard have changed the backdrop from where the Newtown Monument currently stands. These improvements have also created an opportunity to display the Newtown Monument in a more prominent setting.

As discussed on the phone, we will be submitting waivers to the Committee on Alabama Monument Protection for the relocation of 2 monuments within the City of Tuscaloosa. Both proposed relocations have been initiated to accommodate improvement projects where the monuments are currently located. No content will be changed on either monument; we are simply proposing to relocate them to a location that better fits the area after the projects are complete.

The waiver application requires "Written commentary from any heritage, historical, genealogical, or preservation organizations

with an interest in the decision of the Controlling Entity, or from the general public". Given your society's mission for the preservation of the history of Tuscaloosa, I thought you would be a good fit

for that requirement. I have attached images of both monument plaques, as well as maps showing the existing and proposed locations. A brief summary of each location is provided below as well.

We would greatly appreciate your help in reviewing and providing commentary on this proposal. Our goal is to submit the application by next Wednesday, 2/15. If you have any questions on the relocations, please don't hesitate to let us know; we are happy to discuss!

Snow Hinton Park

- Phase 1 of improvements to Snow Hinton Park are currently under design
- Monument plaque will be relocated roughly 420 feet to the southeast
- Plaque may be replaced in the relocation process; the plaque has sustained vandalism since its original installation. No content change is proposed if the plaque is replaced



WAIVER APPLICATION GUIDELINES & COVER FORM

The Alabama Memorial Preservation Act of 2017 prohibits the relocation, removal, alteration, renaming, or other disturbance of any architecturally significant building, memorial building, memorial street, or monument located on public property which has been in place for 40 years or more. The Act provides a waiver process for the relocation, removal, alteration, renaming, or other disturbance of any architecturally significant building, memorial building, memorial building, memorial street, or monument located on public property which has been in place for at least 20 years and less than 40 years, and also provides a waiver process for the renaming of a memorial school which is located on public property and has been so situated for 20 or more years. At a minimum, submission of this completed form and attachments constitutes a request for review by the Committee on Alabama Monument Protection (CAMP). The responsibility for preparing this application and all attachments rests with the Controlling Entity that has legal control of the public property on which the architecturally significant building, memorial building, memorial street, monument, or memorial school sits. A Technical Advisory Review Group (TARG) appointed by the Committee shall review the application, verify its compliance with administrative rules, and make recommendations based on the historical and technical scope of the application. The TARG's ability to complete a timely review depends on the quality of the material submitted.

NOTE: The Committee's administrative rules (*Alabama Administrative Code* 584-X-1) provides for a 90-day response time by the Committee following the submittal deadline. A schedule of Committee meetings and deadlines is available at <u>www.CAMP.alabama.gov</u>.

Current, good-quality photographs of the architecturally significant building, memorial building, memorial street, monument, or memorial school.

Documentation of the origin of the structure, the intent of the sponsoring entity at the time of dedication, and any subsequent alteration, renaming, or other disturbance.

Copy of the resolution by the Controlling Entity seeking a waiver.

Copy of a dated public notice of the Controlling Entity's intent to adopt the resolution.

Documentation that the resolution was presented for public input prior to adoption by the Controlling Entity (minutes of public hearing and/or copy of dated instructions for submitting written comments).

Written commentary from any heritage, historical, genealogical, or preservation organizations with an interest in the decision of the Controlling Entity, or from the general public.

 - A determination has been made that a waiver is not required for the proposed modification.
 - A determination has been made that the proposed modification is not eligibile for a waiver and the application will not be considered by the Committee.
 - The application has been placed on an agenda for consideration by the Committee.
